

**Colchester Baseball Softball League
Covid 19 Precautions Agreement/Liability Waiver**

In order to insure the safety of our players, families and volunteers, the following protocols apply if you or anyone in your family has come in contact with someone with Covid -19 or has symptoms of Covid-19 which include:

- Fever or Chills
- Cough
- Shortness of breath or difficulty breathing
- Fatigue
- Muscle or body aches
- Headache
- New loss of taste or smell
- Sore throat
- Congestion or runny nose
- Nausea or vomiting
- Diarrhea

I agree to the following:

- I understand the above symptoms and affirm that my child, as well as all household members, do not currently have, nor have experienced the symptoms listed above within the last 14 days prior to attending any CBSL event.
- I affirm that I, as well as all household members, have not been diagnosed with COVID-19 within the past 30 days prior to attending any CBSL event.
- I affirm that I, as well as all household members, have not knowingly been exposed to anyone diagnosed with COVID-19 within the past 14 days prior to attending any CBSL event
- I affirm that I will screen and monitor my child for the above-mentioned symptoms prior to each CBSL event
- I will confirm that my child does not have a fever of 100.4 degrees or greater prior to all CbSL events
- I understand that CBSL cannot be held liable for any exposure to the COVID-19 virus caused by misinformation on this form.
- I affirm that by signing this waiver I voluntarily assume all risks associated with Covid-19 that I may be exposed to by attending and/or participating in CBSL events.
- I affirm that by signing this waiver I agree to follow th CBSL safety guidelines registered with the town.
- I acknowledge understanding of the State of Connecticut travel restrictions which includes a 14 day quarantine when traveling in and out of Connecticut from identified states found at <https://portal.ct.gov/Coronavirus/Covid-19-Knowledge-Base/Travel-In-or-Out-of-CT>
- On my behalf, I hereby release and hold harmless, covenant not to sue, discharge, and agree to indemnify the Colchester Baseball Softball League, its elected and appointed officers, coaches, employees, representatives, from any claims, including all liabilities, claims, actions,

damages, costs or expenses of any kind arising out of or related thereto WITH RESPECT TO ANY AND ALL ILLNESS,DISABILTY, DEATH, including but not limited to those related to COVID-19 or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE CLUB OR OTHERWISE, to the fullest extent permitted by law.

- I have read the terms of the agreement and fully understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release and waiver of all liability to the greatest extent allowed by law.
